- The consolidated financial results include the financial results of subsidiary namely Greenpanel Singapore Pte. Limited (Singapore).
- The manufacturing operations at Company's MDF plant situated at Rudrapur, Uttarakhand was closed for a period of 13 days from November 11, 2021 to November 23, 2021, due to addition of new machinery (Mat Heating System) to speed up the production process and increase the capacity utilization by 20% from existing 1,80,000 CBM to revised 2,16,000 CBM (approx.) per annum.
- The manufacturing operations at Company's MDF Plant situated at Rudrapur, Uttarakhand was suspended from November 25, 2021 to December 25, 2021 due to breakdown of component of refiner. The loss incurred due the breakdown of the refiner and Loss of profit due to shut down of the above plant beyond 14 days are covered under Insurance Policy. Insurance claim shall be lodged with the Insurer after ascertaining the amount of actual loss and upon receipt of necessary documents from the OEM.
