SCRUTINIZER'S REPORT

POSTAL BALLOT THROUGH REMOTE E-VOTING OF GREENPANEL INDUSTRIES LIMITED

SUB: Scrutinizer's Report on Postal Ballot through remote e-voting conducted pursuant to the provisions of Section 108, 110 of the Companies Act, 2013 read with rules framed thereunder and General Circular No. 14/2020 dated April 8, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No. 22/2020 dated June 15, 2020, Circular No. 33/2020 dated September 28, 2020, Circular No. 39/2020 dated December 31, 2020, Circular No. 10/2021 dated June 23, 2021, Circular No. 20/2021 dated December 8, 2021, Circular No. 2/2022 and 3/2022 dated May 5, 2022 in view of the COVID-19 pandemic (collectively referred to as 'MCA Circulars') and other applicable laws, regulations, circulars, notifications (including any statutory modification or re-enactment thereof for the time being in force), to transact the special business as set out in the Notice dated 08th November, 2022

Dear Sir,

I, Dilip Kumar Sarawagi, Practicing Company Secretary, (Mem. No.: A13020 and C.P. No.: 3090), have been appointed as Scrutinizer by the Board of Directors of the Company in their meeting dated November 08, 2022 for the purpose of scrutinizing the Postal Ballot process through remote e-voting as per the provisions of Section 108, 110 of Companies Act, 2013 (**"the Act"**) read with rules framed thereunder, general circular/(s) and other applicable laws, regulations, notifications (including any statutory modification or re-enactment thereof for the time being in force) and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015:

I. In terms of Section 108, 110 of the Act read with the rules framed thereunder, the Company had appointed Link Intime India Private Limited as the agency for providing remote e-voting facility to the Equity Shareholders of the Company for the resolution proposed in the Postal Ballot Notice dated November 08, 2022 (**"Notice"**).

II. On account of the threat posed by COVID-19 pandemic and in terms of the applicable MCA circulars, the Company had sent the Postal Ballot Notice only by e-mail to those members whose names appeared on the Register of Members / list of beneficial owners as received from the Registrar and Transfer Agent and who had registered their e-mail addresses with the Company or with depository / depository participants / RTA as on Friday, December 02, 2022. ("Cut-off Date") and hard copy of Postal Ballot Notice along with Postal Ballot forms and pre-paid business envelopes had not been sent to the members for this Postal Ballot. Accordingly, the communication of the assent or dissent of the members took place through the remote e-voting system only.

In accordance with the Postal Ballot Notice dated November 08, 2022 sent to the members, the remote e-voting, started at 09:00 a.m. on Tuesday, December 06, 2022 and ended at 05:00 p.m. on Wednesday, January 04, 2023 (Voting Period).

- III. The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the depositories viz., Central Depository Services (India) Limited (CDSL) and National Securities Depository Limited (NSDL), the Company completed dispatch of the Notice of Postal Ballot as under:-
 - On, December 05, 2022 by e-mail to 1,08,566 members who had registered their e-mail addresses with the Company / Depositories / RTA.
 - In terms of Companies (Management and Administration) Rules, 2014, Newspaper publication regarding dispatch of Notice of Postal Ballot dated November 08, 2022, was published on December 06, 2022 in 'Financial Express' (National Daily English) and 'Dainandin Barta' (Assam edition in Assamese).
- IV. The votes cast through remote e-voting platform were unblocked by me in the presence of Mr. Srijan Sarawagi and Mr. Apurba Das and downloaded from the <u>https://instavote.linkintime.co.in</u> at 06:05 p.m. on Wednesday, January 04, 2023, and I observed that:

Total 291 (Two hundred Ninety One) Members had cast their votes through remote e-voting in respect of the businesses contained in the Postal Ballot notice dated November 08, 2022 and none of the votes cast by Members were found to be invalid.

- V.
